Dennis Francis "Nibsy" Ryan moved from Pompey, NY to Syracuse and opened Nibsy's Pub in 1887 at 201 Ulster Street. Dennis' son, William "Nibsy" Ryan, took over Nibsy's Pub in the 1930s. In 1967, William Ryan sold Nibsy's Pub to "Groucho" Hewitt.

Nibsy Ryan's grandparents were Phillip Ryan and Margaret Ryan who were both from Gleninchaveigh (Glowen), Upperchurch parish, Co. Tipperary. Some of their children came to central NY prior to their arrival with the remaining members of their family in 1852 and they settled in Fabius, NY

Griffith's Valuation

The Ryans highlighted in the Griffith's Valuation for the adjacent townlands of Gleninchaveigh (Glown) and Knockcurraghbola Commons have been identified. The other Ryans and the Kennedys are most likely also connected but the research has not been carried out to determine their exact connections.

Phillip Ryan was the grandfather of Dennis Nibsy Ryan. Jeremiah Ryan was the brother of Mary Ryan who married Edmond McGrath, gg-grandfather of Nancy. Eleanor (Big Nellie) Ryan was the mother of Martin and Patrick Ryan. In the story, *Secrets in an Irish Diary*, she was the Big Nellie who rescued Little Nellie from the Knockamena fairy fort and walked her home again. She is also the gg-grandmother of Con Ryan, Nancy's 5th cousin, once removed, who is the present owner of the Ryan compound at Glown. In the story, Mary Ryan's sister Bridget married the fictional relative William McGrath II.
