## Introduction



FOUR GENERATIONS OF THE NIX FAMILY

The above picture represents four generations in direct descent. All of the people shown in the picture are well known in Cazenovia. The baby is Elizabeth Googin, age 6 months; her father, Walter R. Googin of East Syracuse; her grandmother, Mrs. Charles H. Googin of Cazenovia; and her great grandmother, Mrs. Thomas Nix of Cazenovia. The latter, although 83 years old, is in good health and robust.

Mr. Googin is employed in the East Syracuse freight yards by the New York Central railroad company. He was born and brought up in this vicinity and attended the Cazenovia Union School. He always lived here until he went to East Syracuse.

While researching my own family and several associated families from Onondaga and Cortland Counties I became aware of the large number of Googin families in adjacent Madison County. The initial sources which greatly aided my research efforts were the St. James baptism and marriage records that had been transcribed by the late Dick Barr of Syracuse, NY, There were also the St. James Cemetery records that had been transcribed by the late Dennis Weisskotten of Cazenovia. I was busy at the time with my own research and so I copied the Googin info and saved it in a file on my computer.

In March of 2025, while I was finishing off a paper on the Patrick and Ann McGrath family I came across Googins records again. One of Patrick's granddaughters married a Charles H. Googin of Cazenovia. Finally I decided that the Googin families needed a paper of their own.

The most prolific couple was Richard Googin and Helena Madgett. Richard had arrived in Cazenovia sometime between 1850 and 1855 and he married in 1855. Helena gave birth to 9 children and 7 of them survived to adulthood. Of those who survived, 6 of them married but only 4 had any children. These four marriages produced 14 grandchildren and they will be described in detail. It was possible to show that Richard was a sibling of Thomas Googin, Ellen Googin Fitzgerald and Mary Googin Bagley.

The Robert Googin family resided in the 1st Ward of Syracuse and they had come from Co. Limerick, Ireland. Robert had married Ellen Landers in Ireland and three of their four children had been born in Ireland before the family came to the US in 1850. Robert is not related to the Cazenovia Googin siblings who were from Clondrohid parish in Co. Cork.

Tracing Richard, Thomas, Ellen and Mary in the Irish records met with an abundance of good fortune — there were 12 Goggan families residing reasonably close together. Two of these Goggan families, were living in adjacent Irish townlands and met the criteria of being the parents of the Cazenovia Googins. It came down to a numerical analysis to determine which family was the better fit.

### **BREVITIES**

“— **Mr. Irving Briggs** and **Miss Catherine Googin** were married at St. James parochial residence Tuesday afternoon at two o'clock by **Rev. D. Doody**. The bride was neatly attired in a dark blue traveling suit and the groom wore the conventional black. After the ceremony a reception for the bridal party was given by **Mr. and Mrs. Charles Googin**, of Rippleton, and at 6 p.m. the bride and groom took the West Shore train for Auburn, to speed a brief honeymoon.”

## In Memoriam

(By Mrs. Daisy G. Francis, Erieville)

“As the sun was slowly rising in the east, **Anna Goggan Perry** passed gently into eternal rest on Monday morning, December 20, 1935, at the home of her sister, **Mrs. Irving Briggs**, Franklin street, Manlius, where she had made her home since the death of her husband, May 1921, fourteen years ago. She was born in Cazenovia April 25, 1867, the daughter of **Richard** and **Helen Goggan**. She graduated from the Cazenovia Union School and the Cazenovia seminary. For fourteen years she was a successful teacher in several communities the last four in Erieville, and two after her marriage to **Herbert E. Perry**, March 30, 1897.

“She possessed those fine qualities of dignity and grace which made her a charming hostess in her home she so dearly loved during the many years she resided here. A woman of education, culture and refinement with an unusual keen intellect, well versed as a philologist, she expressed her thoughts fluently in prose and rhyme. She was deeply interested in all activities that appertained to the good and uplift of our community. May 30, 1914, she organized the Cornell club, of which she was president for ten years, until 1924 when she resigned and became its honorary president and continuing as one of the hostesses to the last. She also founded our public library as an extension work of the club, getting the necessary data from Albany, which has continued to supply the people with a fine class of reading. She was also a member of the W.C.T.U. She was active in all when her health permitted, doing whatever was required of her cheerfully, enthusiastically and efficiently. For many years she was the regular correspondent for The Cazenovia Republican, The Madison Leader and other papers, even continuing after she went to live in Manlius, gleaning the items from letters she received from her former home town.

She has written many interesting articles for the Manlius Eagle bulletin and other papers while there. She was obliged of late years to give up many of the pleasures she had enjoyed formerly owing to her failing health. In intellectual culture she found much pleasure in the acquisition of knowledge as revealed to her in books and in the study of all constructive topics, which provided her with deep interest and observations in many subjects. The source of her faith from whence she received her strength, comfort and courage to carry on amidst her sufferings, was shown with the brilliancy of illumination from the beautiful letters received from her by her close friends since leaving Erieville. Her friends received even this Christmas gifts from her with loving messages when she was nearing the end.

“She had been very tenderly cared for with sincere and loving devotion by her sister Katie, to whom may this be a comforting message

May the precious thought that your Father knoweth  
And careth for you His child  
Comfort you as you nestle closer to Him  
Now while this storm of sorrow beats wild.  
Though your heart and home are saddened  
And the tear drops gently fall  
Yet may He be your strength and solace,  
Your support and your all in all.

“The last sad rites were held at her late home Thursday, January 2, 1936, and burial here beside her beloved husband, for whom she had mourned so deeply since his decease. Many friends from here and other places were present and the abundance of flowers were mute symbols of the love and esteem in which she was held. She will be greatly missed in her home and in all places where she has been honored and respected. One brother, **Charles Goggan** of Cazenovia, survives, besides her sister.

“We extend our sincere sympathy to all who were near and dear to her. The deeds Anna did with a loving mind.

Came from her heart and with thoughts so kind,  
That they'll shine with the luster of a golden ray,  
And be remembered and cherished for many a day.

## DEATH CAUSED BY NEGLIGENCE, SAY CORONER

### N.Y.C. BLAMED FOR ACCIDENT IN DEWITT YARDS WHICH TOOK LIFE OF WALTER GOOGIN

“The New York Central Railroad Company is charged with gross negligence in the decision rendered this morning by **Coroner Crane**, following the inquest into the death of

**Walter Googin**, 24, who was killed in the DeWitt yards last Thursday morning. At the time of the accident Googin, who was a yard conductor, was riding on the side of a string of freight cars going west in the yard. An engine backing up with a string of cars on a parallel track was also running west.

“Just prior to the accident a third train had crossed over the tracks and instead of closing the switch afterwards had left it open. Just as the cars on which Googin was riding passed opposite the open switch the engine backing up with the string of cars crashed through it and collided broadside with Googin’s train. The young conductor was badly crushed and died instantly. Two freight cars and the entire engine were badly damaged.

#### **EMPLOYEES ARE EXAMINED**

“The crews of the trains involved and yard employees were examined by **Coroner Crane** this morning. The witnesses were: **B. Case, A. Mestler, G. Bastian, F. Foster, and E. Jaquays**. The railroad company contended that while the crew of the train which opened the switch should have seen that it was closed, the crew of the train which collided with Googin’s train should also have seen that the switch was properly set. However, nothing was brought out to show that Googin was negligent in any way.

“Coroner Crane’s decision follows:

From the evidence taken at the inquest and as a result of my personal investigation into the death of Walter Googin. I find that he came to his death as a result of a collision between a locomotive and a string of freight cars in the New York Central yards at DeWitt, Feb. 10.

The testimony taken at the inquest shows that previous to the collision, the crew of a third train opened a switch on a track extending parallel to the one on which Googin’s train was being run. The crew of this, the third train, should have seen that this switch was closed after they had finished operating over it. However, the crew of the second train should have noticed that the switch was open, and it was the duty of both to see that it was left in a safe condition.

The negligence and it appears that there was gross negligence, lays between the crews of the second and third trains. I also find that Googin was properly engaged in his duties and was in no way responsible for the condition.”

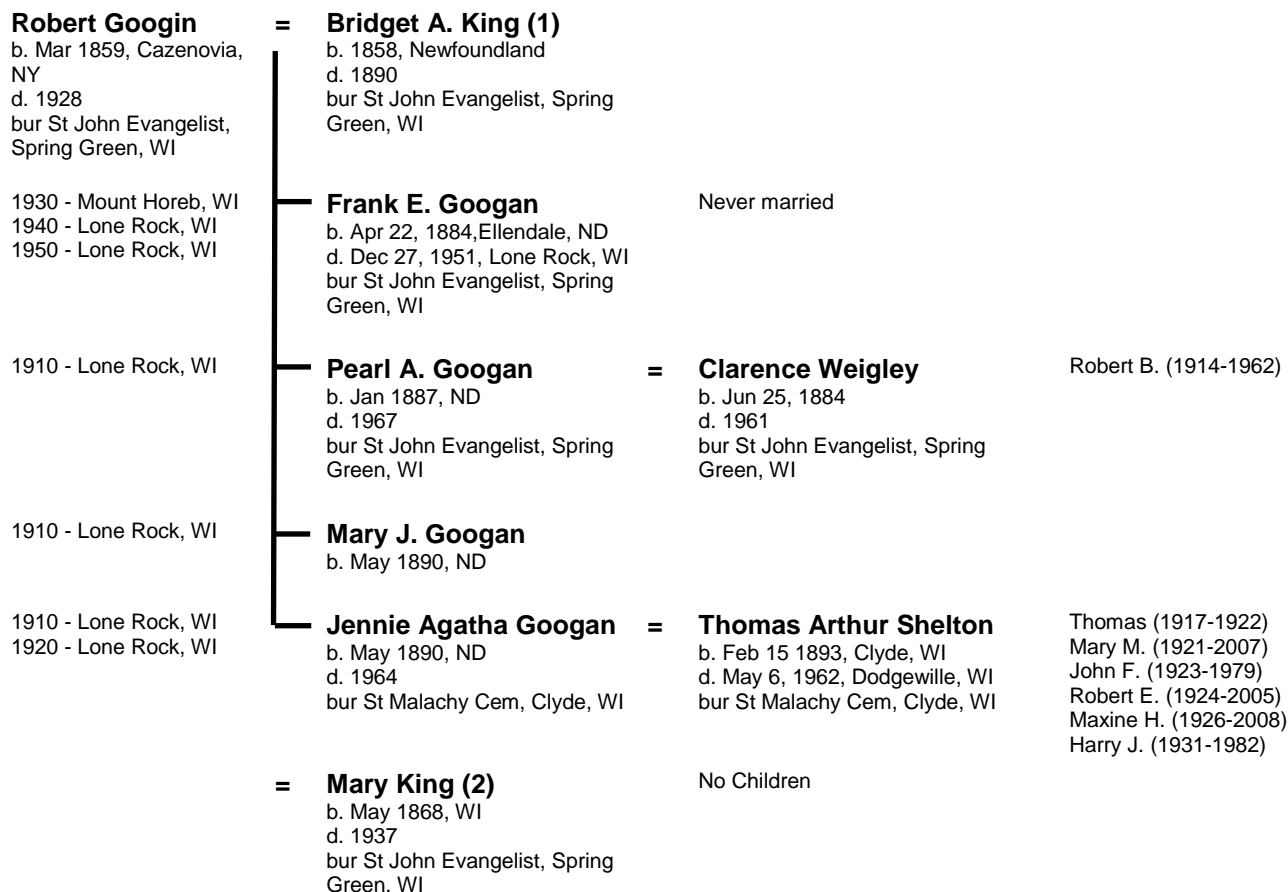

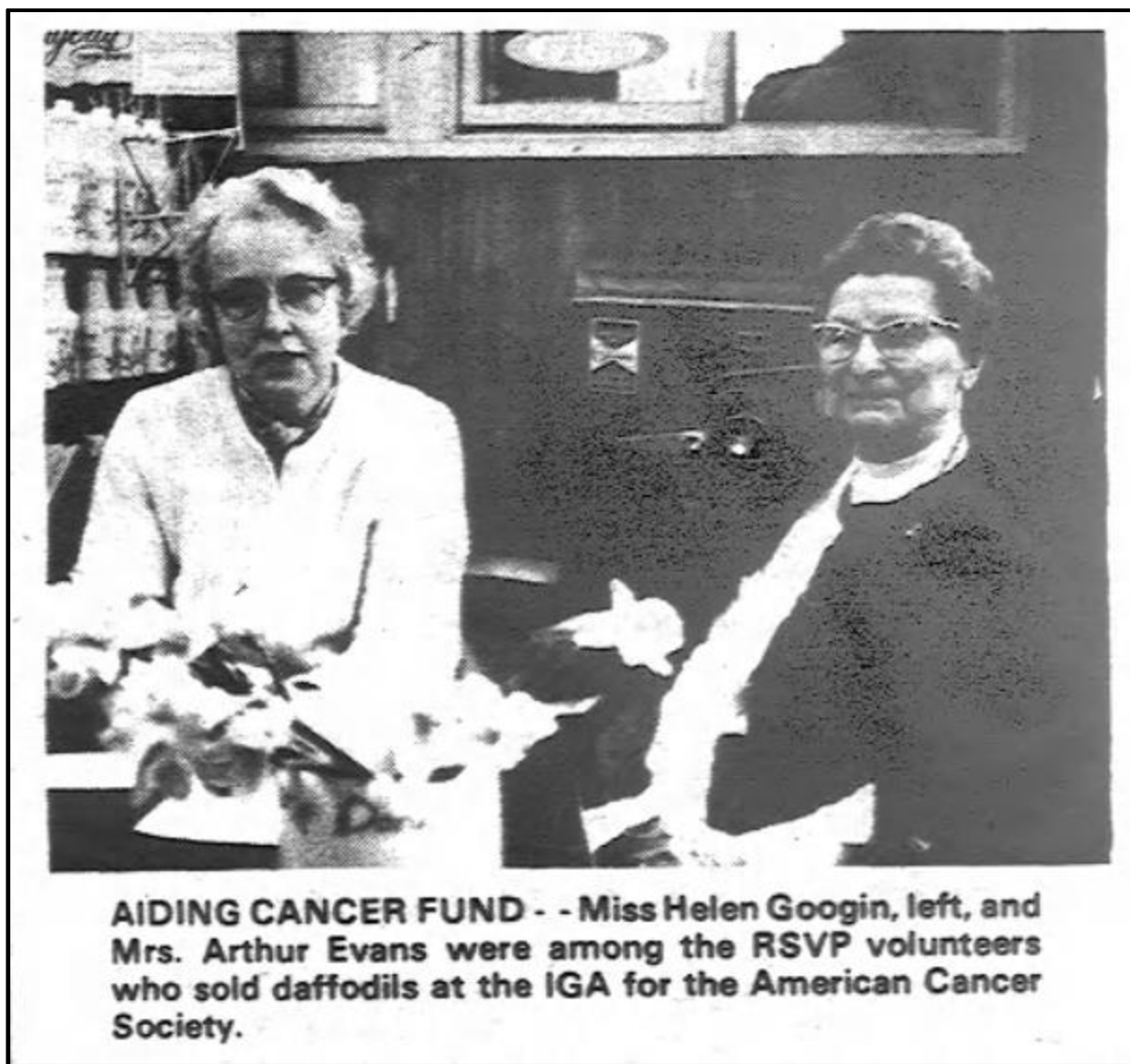

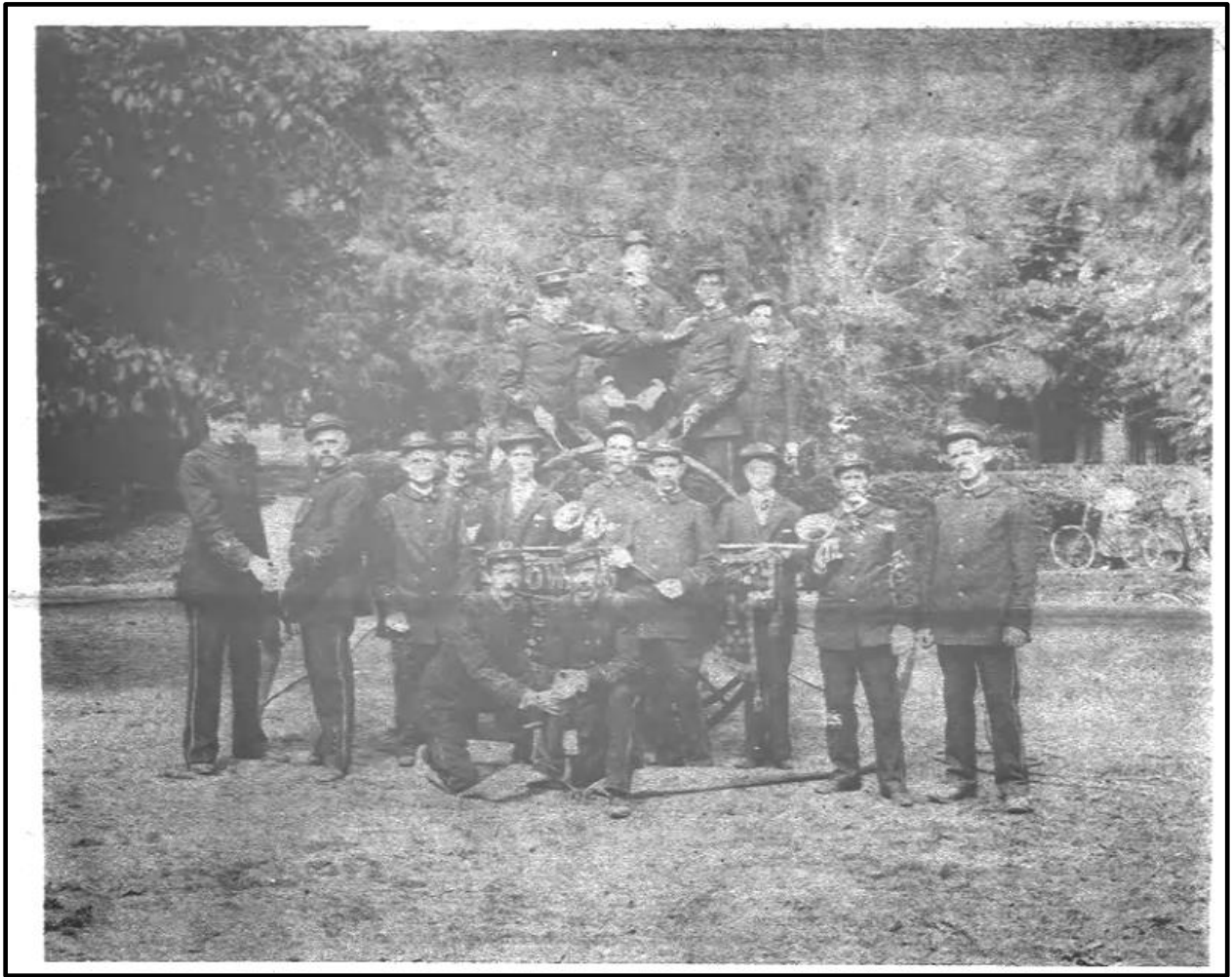

### Death of Nicholas L. Googin

“**Nicholas L. Googin**, 63, for thirty-three years superintendent of the Owahgena Club and Cazenovia Club Corporation, died at his home Thursday (June 17) after a week’s illness. He had been in poor health some time, but was about as usual and was at the club house the day he was taken ill.

“The funeral was held Monday morning at 9 o’clock at his late home and at 9:30 o’clock at St. James church, **Rev. T. H. Quinn** saying a requiem high mass. Burial was made in St. Agnes cemetery.

## **HORSE AND WAGON TAKEN THE HORSE RETURNS BUT THE THIEF ESCAPES**

“OLD PRINCE,” A FORMER EXPRESS HORSE. APPROPRIATED AND ABANDONED NEAR POMPEY BY A LAWLESS CHARACTER

“Last Thursday evening **Mr. Richard Googin**, who works for **Mr. Meredith** at Fernwood Farm, south of the village, drove to town to do some shopping and hitched his horse ‘**Old Prince**’ for many years the express horse, in the public sheds in the rear of the Cazenovia House. He made some purchases and carried the parcels out and put them in the wagon and came back to the store for other purchases. Upon returning to the sheds about ten or fifteen minutes later he found his horse and wagon gone.

“Mr. Googin returned home and about three o’clock in the morning the horse came home dragging a broken wagon.

“**Deputy Sheriff Hulbert** was notified and he traced the rig over the hill to Pompey Hollow, and about two miles from there he found where the parties had run into the corner of a barn and wrecked one wheel of the wagon, Here the rig was entirely abandoned and the horse returned home.

“The party or parties who took the rig have not been apprehended. A man was seen to go to the sheds a short time before the horse was taken and a man answering the same description who also was later in the vicinity where the rig was abandoned. The same person was earlier in the day looking for a chance to get to Delphi, and as he was in an intoxicated condition, it is thought that it was he who appropriated the horse and wagon.

### Mrs. Hoyt, Ex-Director Of Recreation, Dies

“**FUNERAL SERVICES** will be conducted in Syracuse at a time to be announced for **Mrs. Helena G. Hoyt**, former director of the Syracuse Recreation Department who died yesterday (Oct 19) afternoon in New York City.

“Mrs. Hoyt, an employe of the National Recreation Association died in French Hospital following a cerebral hemorrhage.

“Mrs. Hoyt became associated with the city recreation department 38 years ago. She was appointed director in 1945. Under her guidance the city’s recreation program won national recognition.

“**SHE RESIGNED** her post here Jan. 29, 1951, after the Board of Estimate failed to increase her \$4500 annual salary by 1,000 and accepted a position with the National Association.

“At the time of her death, Mrs. Hoyt, who lived in New York City, had returned from a six-week tour of southern states where she organized recreational programs at Army camps. She was stricken while visiting her daughter, **Jane**.

“Besides her daughter, survivors are two sons, **John T. Hoyt** of Syracuse and **David Hoyt**, who lives near Auburn.”

## Searching For Googin Connections

In an attempt to find possible early connections among the Googin individuals found in the Madison County area during the research for this paper they have been gathered in the table below. The criteria for being included in this table the individual needed to be born in 1830 or before. The persons found so far were born between 1815 and 1830, which is an interval that would make it feasible that these individuals might be siblings or perhaps cousins.

Two of these individuals, Richard and Thomas Googin, have been researched in detail and a possible sibling relationship between the two has been developed. The awareness of the rest of the Googin individuals found in this list was discovered by their appearance in one or two records. Efforts have been made to expand the knowledge on each of these individuals in an attempt to establish any possible relationships.

### MRS. MARY BAGLEY

“Died at her late residence on Albany St. Friday, April 11 of pneumonia, **Mrs. Mary Bagley**, aged 78 years. Mrs. Bagley was born in Ireland and came to Cazenovia in 1854 in which place she has since resided until her demise. Her illness was of short duration, being confined to her bed only five days, when God’s grim messenger, death, claimed her for his own. She bore her sufferings with patience and fortitude and often during her illness expressed a desire to be with God, and when the final hour came she was reconciled to the Divine will of him who says: ‘Now therefore you are no more strangers and foreigners, but you are now fellow citizens with the saints and domestics of God.’ She leaves an only sister, **Mrs. E. Fitzgerald** of Belmont, to mourn her loss and to her we express our sympathy. Her funeral took place at St. James’ church, Monday; interment at Cazenovia.”

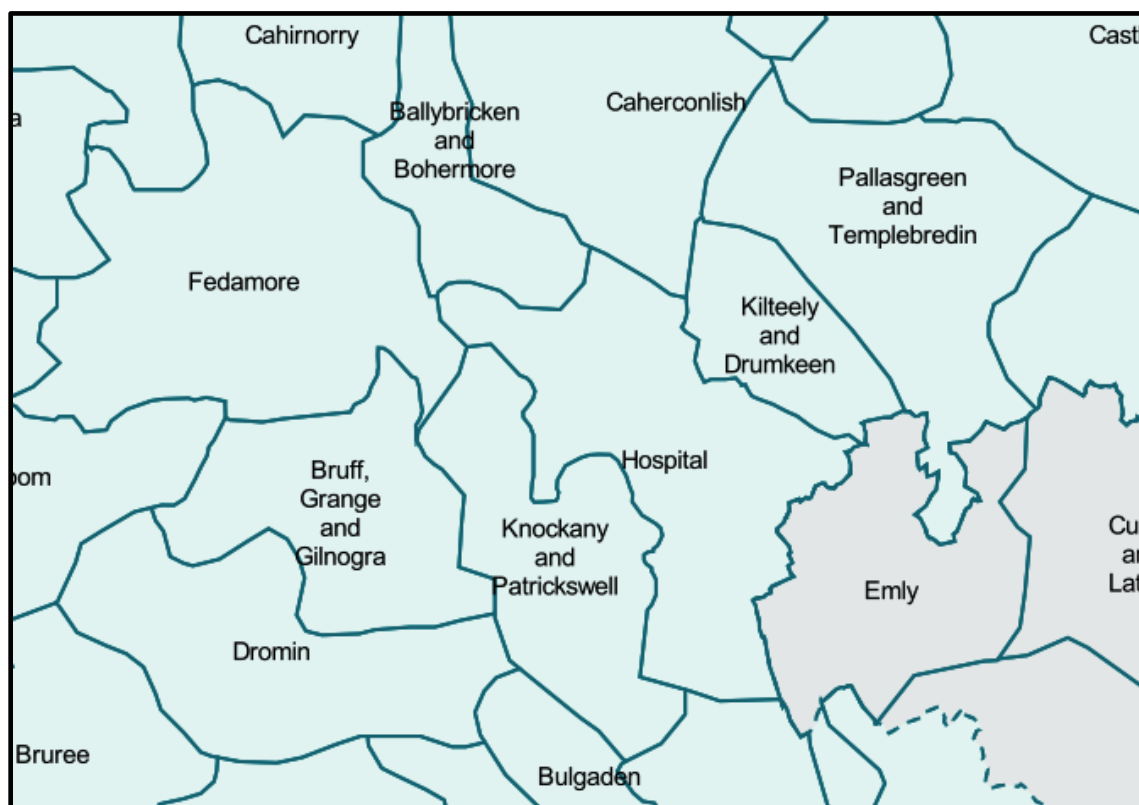

### ALLEGED ABDUCTION

#### A Case in Which Syracuse and Elmira People Figure

“**Mrs. Ellen Power**, of this city, has sworn out a warrant for the arrest of **Mrs. Regina Smith**, of Elmira, charging her with the abduction of **Margaret E. Dunn**, of this city. Miss Dunn is 19 years of age and is the daughter of the late **Patrick and Mary Dunn**. She has no near relatives. She has been a student of the Syracuse Medical college. **Ellen Power** is the widow of Lawrence Power, and at present resides upstairs at 310 Court street. She was a cousin of **Mary Dunn**, the dead mother of **Margaret**. **Regina Smith**, is the wife of **Ernest A. P. Smith**, of Elmira, a cashier of one of the Elmira banks. **Mr. Smith** was a student with **Miss Dunn** at the



Medical College. **Margaret Dunn** applied to Surrogate **Edgar P. Glass** last March to have a guardian appointed. She stated that she was 19 upon the 21<sup>st</sup> of October last, and that she desired **Ernest A. P. Smith** to be appointed. Objections to the appointment were raised by Mrs. Power, but they did not stand, and it was made on the 14<sup>th</sup> of April. In the petition for the appointment of a guardian Miss Dunn stated that her property consisted of three houses and lots and a vacant lot in the city of Augusta, Ga., valued at \$?, 000, from which a yearly income of \$300 was obtained. Also an insurance policy for \$1,000 upon the life of the late **Mary Dunn** in the Ladies' Catholic Benevolent Association of Buffalo.

"Miss Dunn had been living with Mrs. Power after her mother's death and illegible to the application for the appointment of a guardian. She then went to the residence of the Smiths in Elmira, and shortly thereafter sent to Syracuse for her clothing. Her attorneys sought the services of the sheriff and **Deputy Bennett** went to **Mrs. Power's** house and demanded the clothing. He was told that if **Miss Dunn** wished her clothing she must apply in person. **Mrs. Smith** will come to this city to answer the charge against her."

## Obituary

### A DOUBLE SCENE OF SORROW

#### Impressive Services at the Church of St. John the Baptist

"This morning, at 8 o'clock, in St. John the Baptist's church, was celebrated the second anniversary of the death of **Martin Tierman** of Holland Patent, the father of **Rev. Joseph S. Tierman** of this city. A solemn requiem mass was chanted in the presence of many friends and school children. The sanctuary boys filled the sanctuary and sang the responses of the mass. **Father Tierman** acted as celebrant assisted by **Rev. William F. Griffin** of Oswego, formerly of Whitestown, and who prepared the deceased for death, and **Father Murphy**, who preached his funeral sermon. They acted as deacon and sub-deacon respectively, **Prof. M. P. Champaux** presided at the organ. Scarcely had the strains of the solemn chant died away, when the great bell in the tower began to toll the funeral notes for a deceased sanctuary boy, **Lawrence R. Powers**, well known and greatly beloved, but 18 years of age, and the only son of his widowed mother, had after a brief illness of two weeks, succumbed to a violent attack of typhoid fever. His last act, before taking to his bed, was to serve at the holy sacrifice of the mass, and being so often seen, about the church and esteemed by all who knew him, his sudden and unexpected death awoke the liveliest expressions of sorrow among the children and youth of the parish, and spread a gloom over their young hearts. At an early hour they gathered from their homes and filed into the church, and were in waiting when the funeral procession arrived. The members of the Junior Sacred Heart Sodality, of which the deceased was an active member, accompanied the remains from the house and occupied reserved places in the church, at the right of the remains. **Masters Frank Crosby, William Loughnot, William Slattery, Owen Small, Martin Hanley, Charles O'Donnell**, acted as pall-bearers. **Rev. John F. Mullaney** acted as celebrant, assisted by **Rev. Fathers Griffin**, as deacon, and **Tierman** as sub-deacon. The sanctuary boys, in draped surplices and cassocks, chanted the responses, and sang, after the consecration, St. Bernard's hymn to the Blessed Virgin. The services were very solemn and impressive. The sermon was preached by **Father Mullaney**, and was an exhortation, Earnest and Eloquent, founded on the union of three Scriptural texts: 'The raising of the widow's son to life,' St. Paul's words, 'To

sorrow not as those without hope in a future life,' and the words of Maccabees. 'It is a holy and a wholesome thought to pray for the dead.' It was a touching tribute to the good dead boy, calculated to impress the hearts of the young with the determination to imitate his example, and to console with Christian hope the sorrow of the bereaved mother.

"At a special meeting of the sodality last evening the following memorial resolutions were adopted: —

"Whereas, It has pleased Almighty God in His infinite wisdom to call from our midst our beloved member **Lawrence R. Power**; be it

"*Resolved*, That we bow in humble submission to His almighty will, and that we feel that we have lost a model young man, a faithful member and a beloved brother.

"*Resolved*, That we deeply sympathize with his sorrowing mother in her sad affliction.

"*Resolved*, That our society rooms be draped in mourning for thirty days; that two copies of the above resolutions be engrossed, one to be presented to the mother of our dead member, the other to be hung on the walls of our society rooms, to be a reminder of the sacred resolutions we have this day made."

## **WELL KNOWN SISTER DEAD**

### **M. Mechtildes Dies at Hospital After a Long Illness — Funeral Arranged**

"**Sister M. Mechtildes**. Formerly Miss Mary Goggin, daughter of the late **Robert** and **Ellen Landers Goggin** of Syracuse, died this morning (May 31) at St. Joseph's Hospital after a long illness.

"She was born at Limerick, Ireland, September 3, 1848, and was received in the Third Order of St. Francis at St. Anthony's Convent, April 19, 1865. She received the holy habit October 4, 1865, and took her final vows on the same day one year later.

"After her profession Sister Mechtildes was transferred to St. Patrick's School at Utica, where she remained three years. She was then transferred to St. Joseph's Hospital, where she remained up to two years ago, when she entered St. Elizabeth's Hospital at Utica. Nearly one year ago her health failed and she returned to St. Joseph's to rest, intending to again assume her duties at the Utica Hospital.

"She is survived by one sister, **Mrs. Ellen Powers**. The funeral will be held Saturday morning, with offices for the dead at 9 a.m. at St. Anthony's Convent in Court st. and high mass of requiem at 9:30."

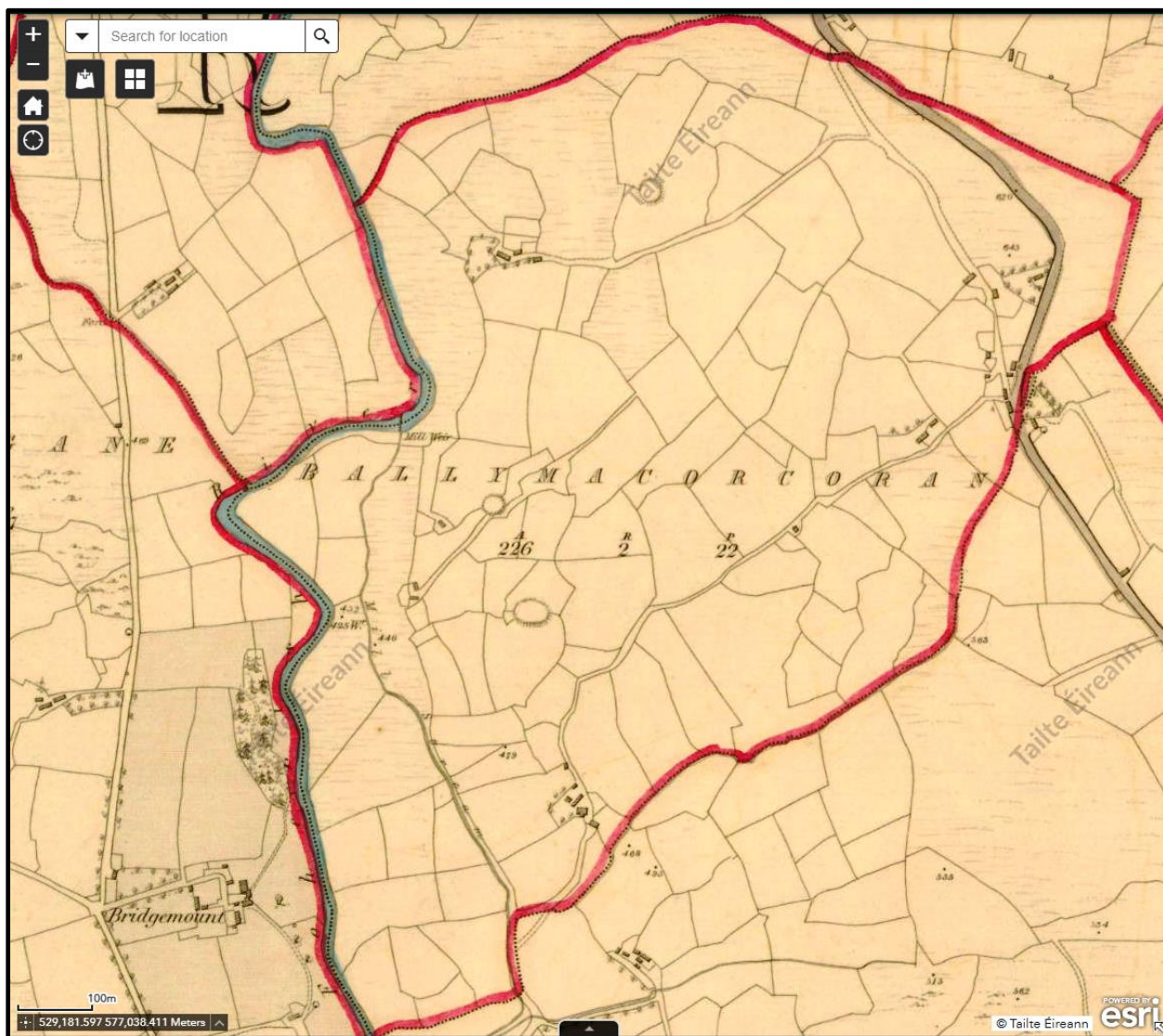

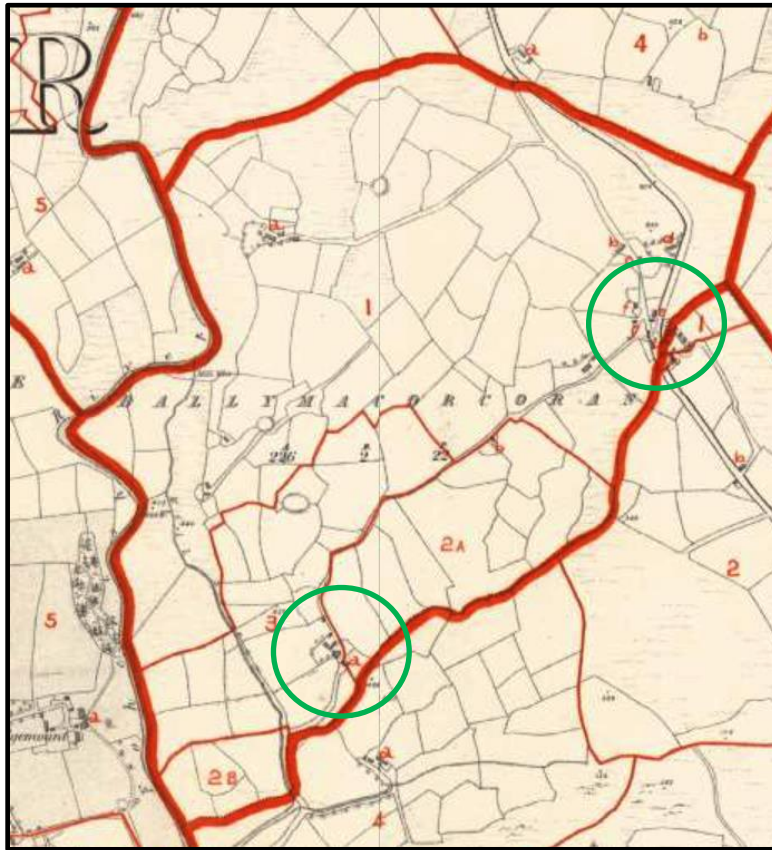
## Map of Ballymacorcoran

The Ordnance Survey map shown on the previous page was created (1829 - 1842) as part of the Griffiths' Valuation project. They helped guide the valuers who were gathering information on the occupiers and the amount and value of the land that they occupied. After completing an area a publication called Griffith's Valuation for that area was printed. The Macroom Poor Law Union was published in November 1852. The valuers in that area would also receive a manuscript copy in which they would record the changes in land ownership in their respective areas over the coming years. When the manuscript copy became full of changes it was returned to the Valuation Office in Dublin where it became known as a "Cancelled Book." A new, updated manuscript would be returned to the local valuation officers. Maps like the one above date to the time of the first cancelled books as can be seen to compare very well with the current information. All the maps the author has seen have evolved from the occupation patterns found in the printed valuation.

All the ownership of the various parcels of land change so do the numbering of the lots — they are not sacred. The lower numbers remain more stable than the higher ones. If there are any changes then the largest number will change to reflect the new ownership. As can be seen in the map above the 35-acre parcel held by Francis Goggan at the time of the GV publication is not here at the time of the first closed book (circa late 1860s). In the map above Lot 3 is 33.248 acres while Lots 2A and 2B are 34.013 acres. Therefore the old Lot 4a was absorbed into Lot 2. The two areas marked by green circles mark where the building are located and the will be examined in more detail on the following pages.

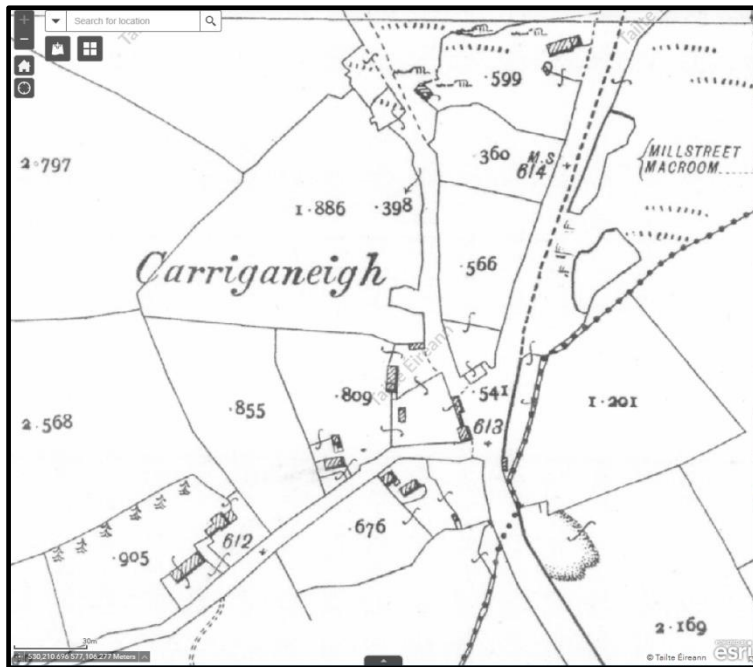


## Enlarged View of NE Corner of Ballymacorcoran



This is an enlarged version of the northeast corner of the townland of Ballymacorcoran. The lot occupied by Francis Goggan “Lot 1e” is still shown on this map. On the 25-inch map which was issued around 1900 this grouping of structures was named Carriganeigh which would make this small region a sub-townland in the larger townland of Ballymacorcoran.

## The 25-inch Map of Carriganeigh

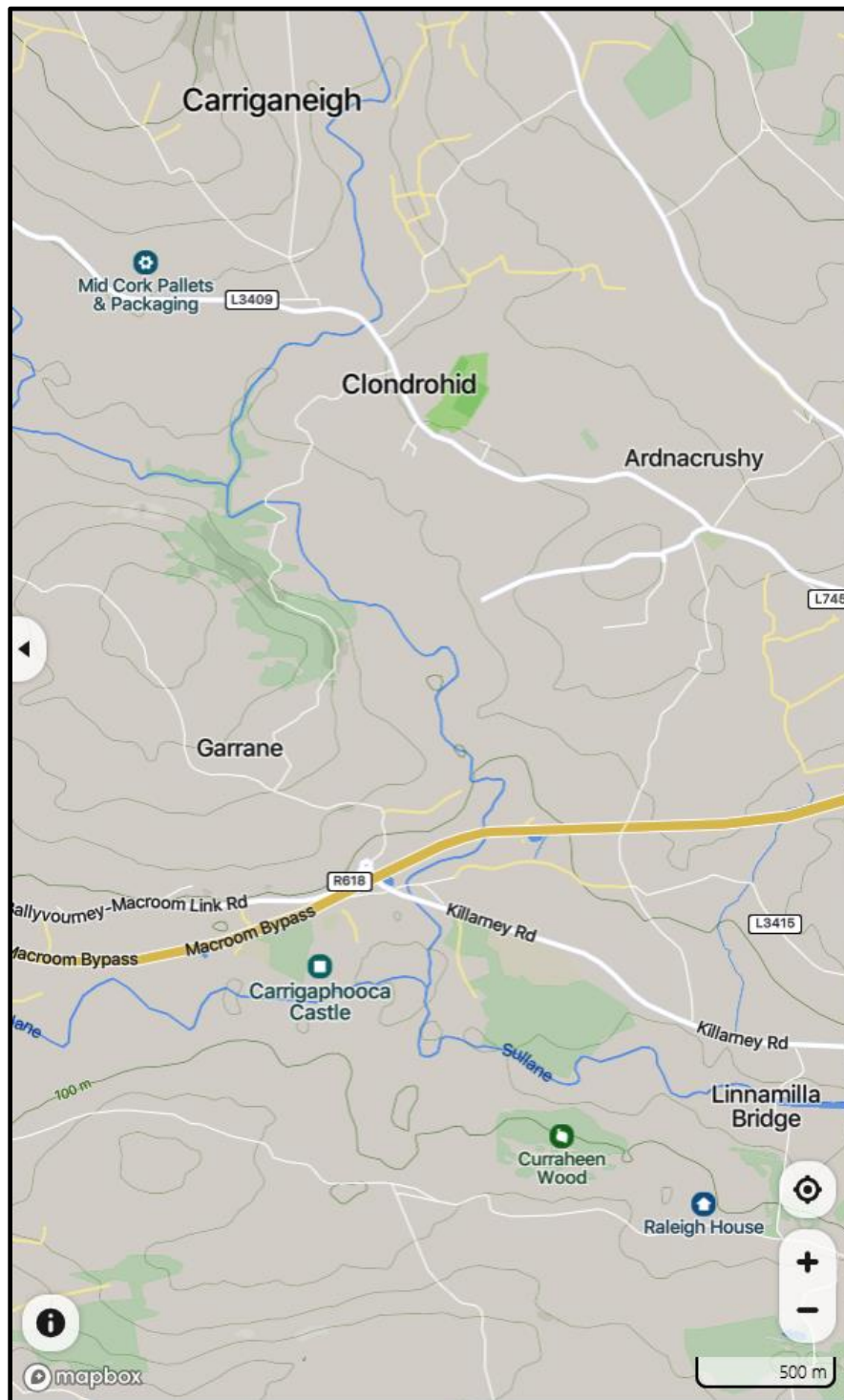


The 25 inch maps were produced from 1888 to 1915. They arrived around the beginning of the agrarian reforms in Ireland. The maps were said to be needed by the landlords to transfer ownership of the land to tenant farmers. The 6-inch maps didn't have enough detail.



A satellite image of the same area from 2013. After examining this image at a higher magnification there doesn't appear that any of the old homestead cabins have survived the rages of time.

## The Sub-Townland of Carriganeigh



Sub-townlands are not officially recognized as administrative units. Officially the townland is the smallest unit. The sub-townlands or neighborhood names arise in an attempt to describe regions in a large townland. They can come and go and sometimes just fall out of use but in the case of Carriganeigh the scrappy little sub-townland is still holding its own.

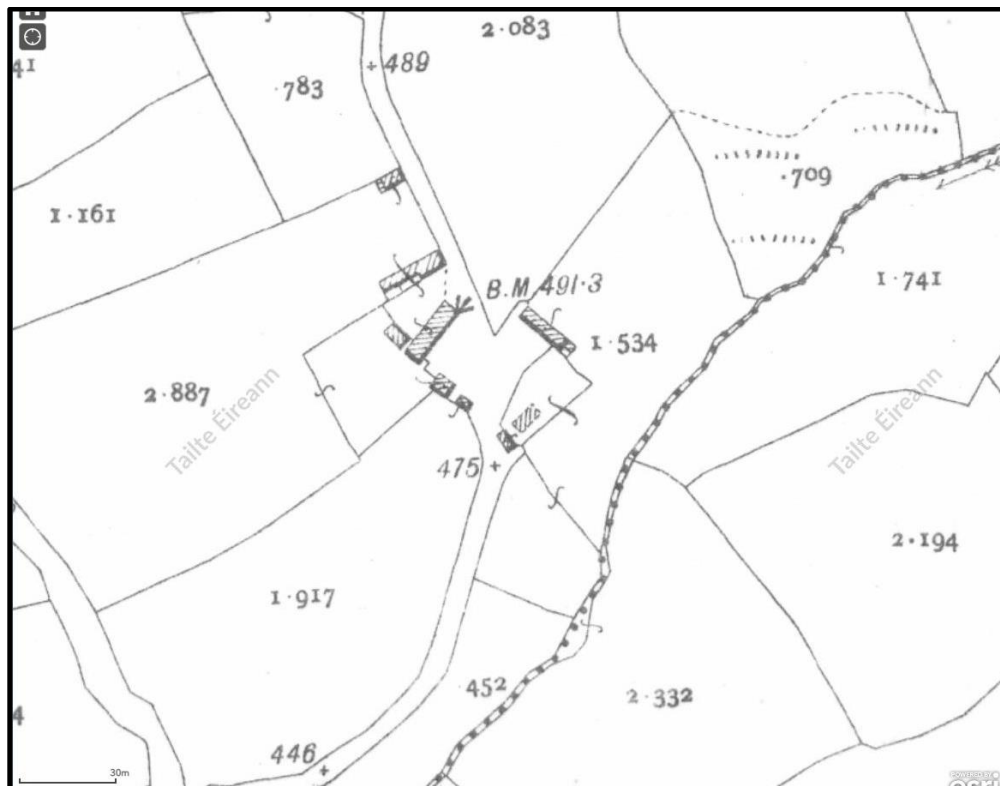

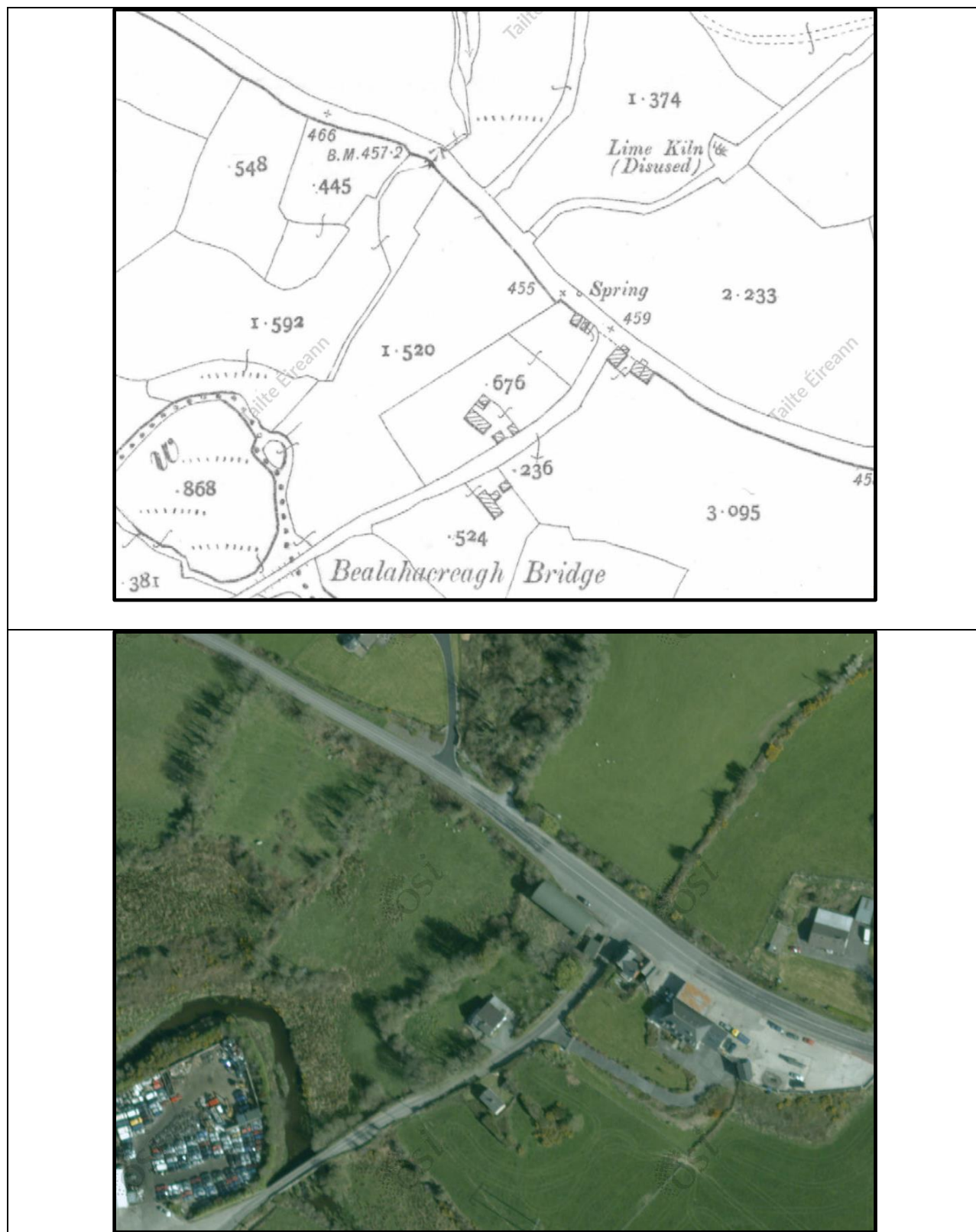

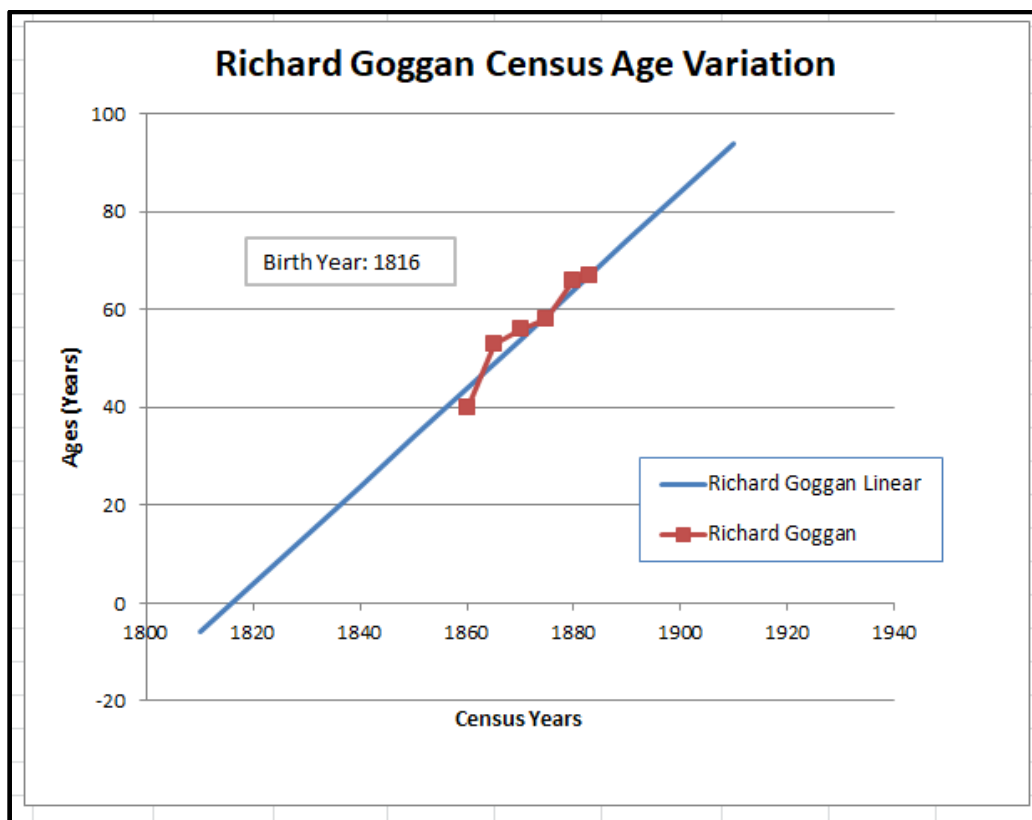
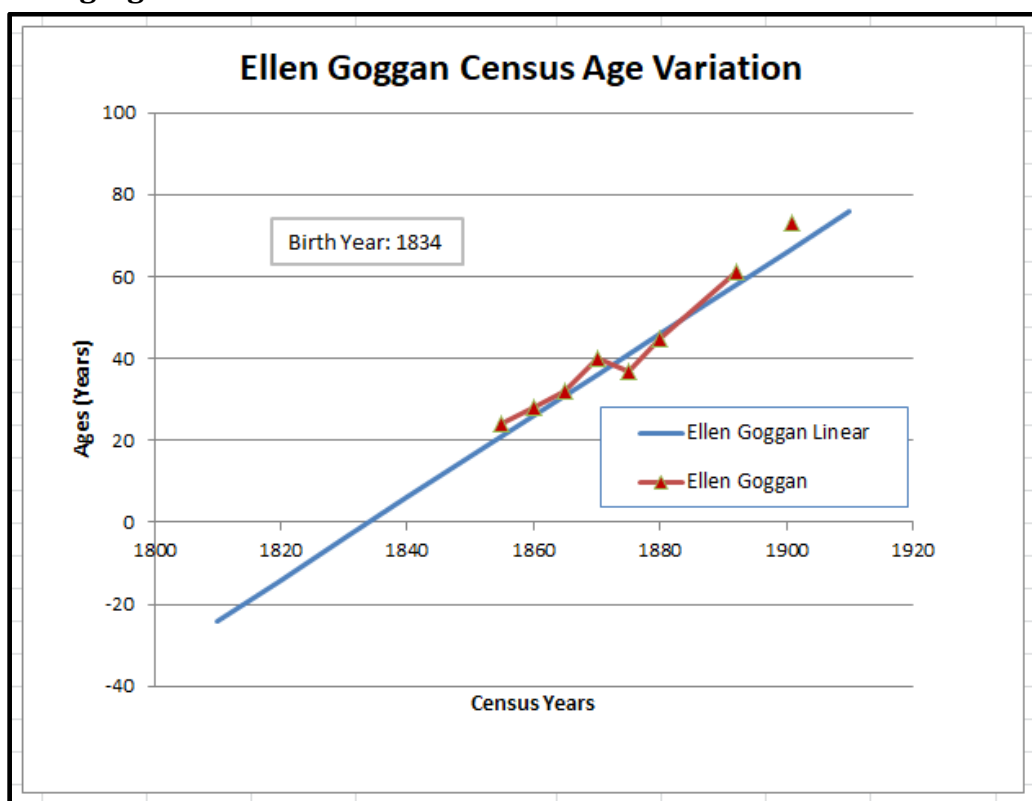

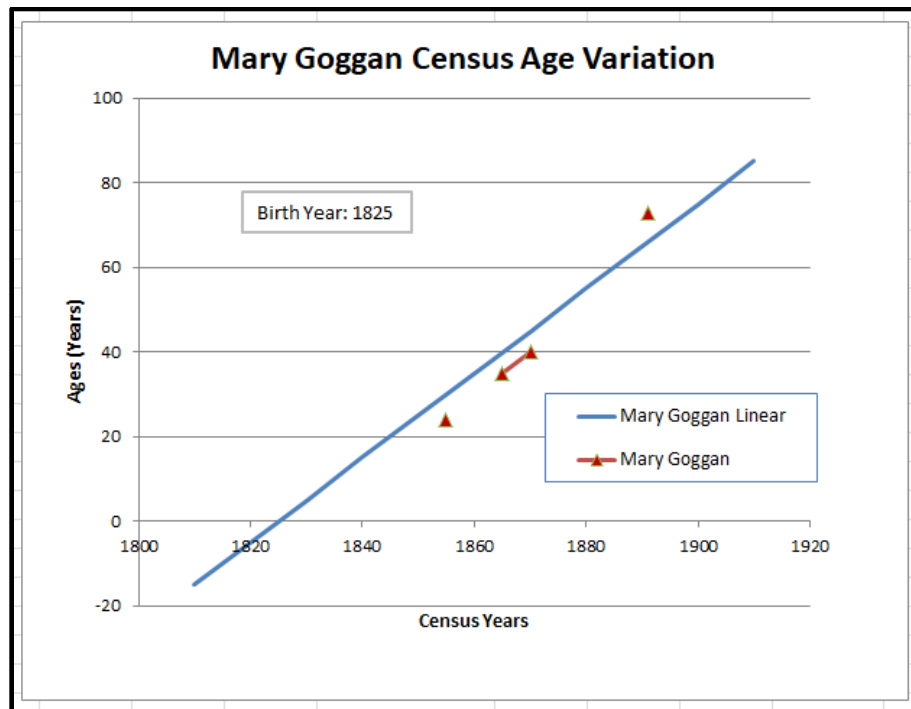

R. M. S. refers to a Root Mean Square calculation. Its purpose is to measure how close the baptism years in a given family are to the best fit birth year estimates obtained from the census ages and the age at death (if known). The upper number includes Ellen (1<sup>st</sup> column) and the lower number just uses the other three children. The smaller the number the better and this is used to decide which family is the actual family of Ellen Richard, Mary and Thomas. On the following pages are shown the graphs that were used to determine the Best Fit Birth Year Estimates.

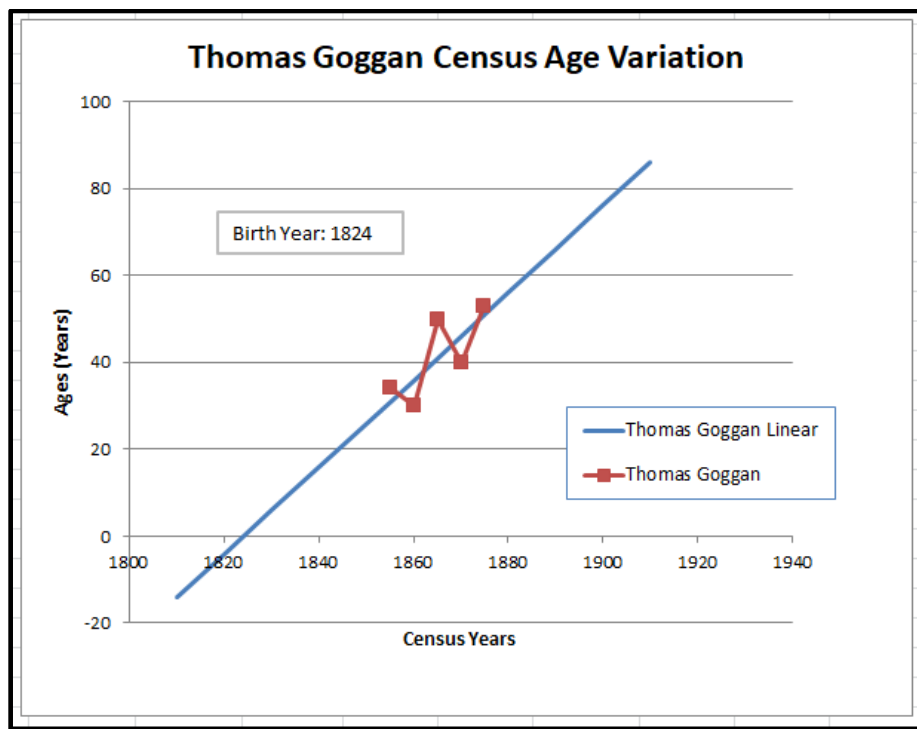
## Graphical Aging Fits - Ellen and Richard



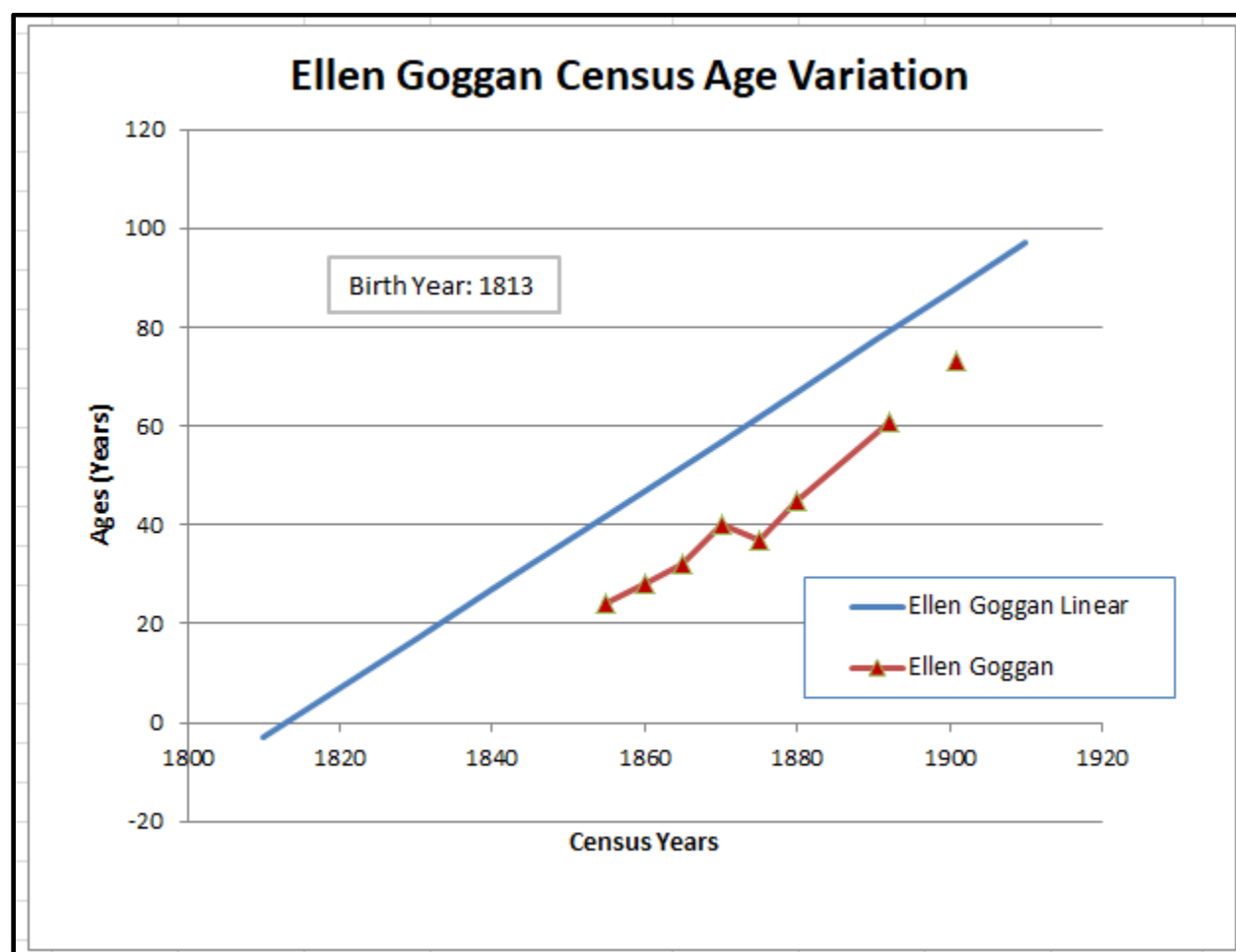
## Graphical Aging Fits - Mary and Thomas



Mary disappeared from the census after 1870 and so there are very few data points on which to base her birth year estimate. Her obit put her age at 78 and her gravestone put her age at 73. If more weight is given to these ages then Mary's birth year will move closer to that of Francis Goggan's daughter Mary.



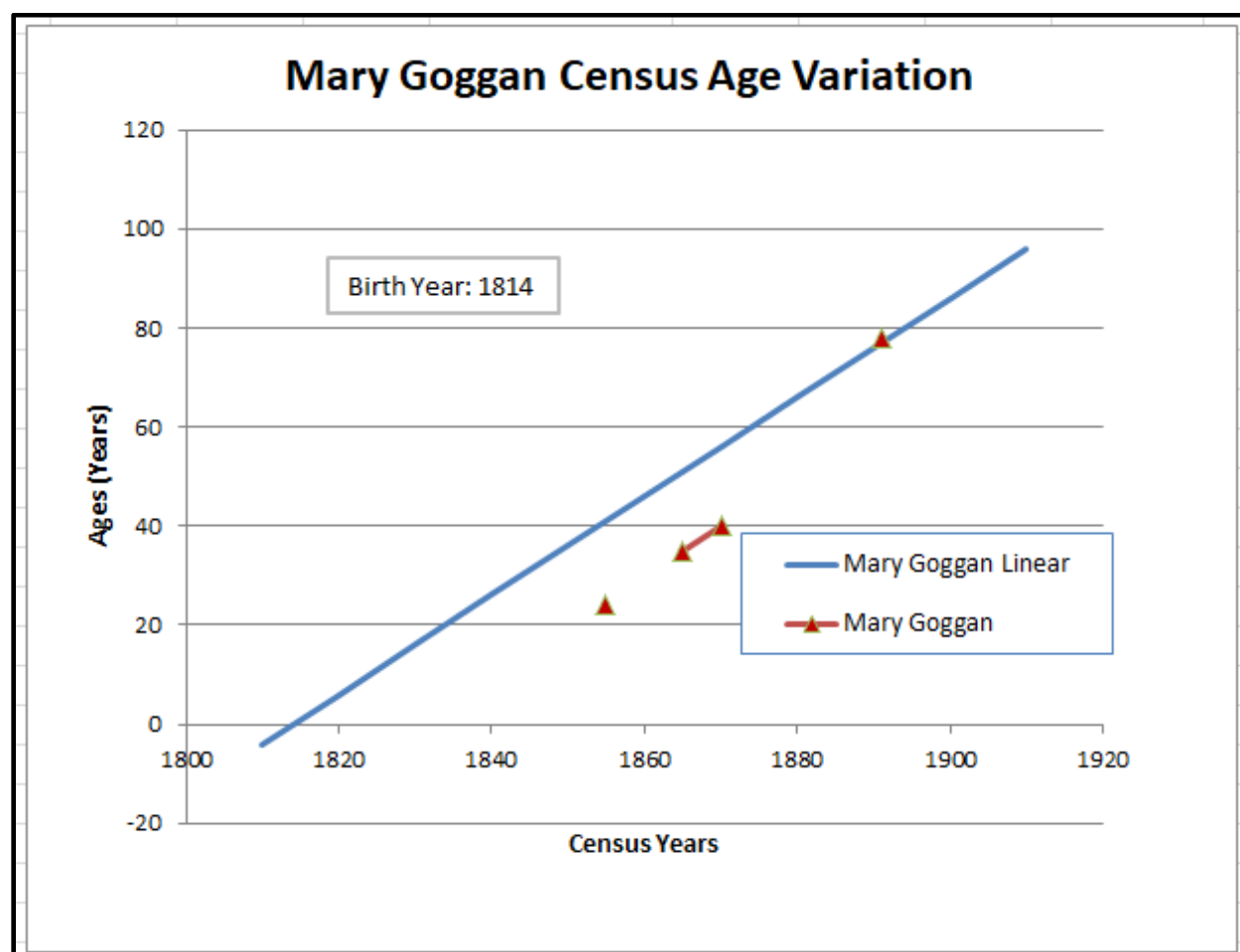
## Ellen's Curious Aging



There are always variations in the ages found in the census records. One or the other of these two families might be the ancestors of the Goggins of Cazenovia. Is it possible that a person, Ellen for instance, could knock 21 years off her true age and get away with it. In 1855 she was telling people that her age was 24 when she was actually 42 years old. She gave birth to children in 1861, 1863, and 1865; at which time she would have been 48, 50 and 52 years of age. There is a pattern seen before in young unmarried woman. At first they age more slowly than normal trying to keep their age young while they hope for a husband to come along. Once they are married their age resumes its normal progression, because her husband and all her children know her age. As the woman gets older she starts to become proud of her age and it will start to accelerate towards her true age — sometimes even exceeding her true age at the time of her death. Ellen doesn't follow this pattern. She just dropped some 20 years off her age and then stuck to that story all the way to her grave.

In some respects putting together a family tree and a lot like doing a puzzle, except there is no picture on the top of the box to guide you and in fact the box is mostly empty and you have to find your own puzzle pieces. When the pieces are found they don't always fit and they have to be shaved or adjusted a bit.

## The Case of Mary Goggan



In the case of Mary Goggan the situation is suffering from a lack of data. The family was not found in the 1875 and 1880 census and then Mary died in 1891. In her obituary it said that she died at the age of 78. The following scenario is proposed whereby Mary lowered her age when she was younger but not as severely as her sister Ellen. Then, toward the end of her life she began admitting her real age. It will be assumed that her obit age was her actual age when she died. In that case when the blue line is moved so that it passes through her age of 78 in 1891 it produces a birth year 1814.

Frank and Margaret's daughter Mary was born in 1819 and John and Julian's daughter Mary was born in 1830. This will reduce the difference for the former family and increase the difference for the latter. This reduces the RMS number for the former family to 3.37 from 3.87 and increases the RMS value to 11.61 from 7.59 for the latter family. The Frank and Margaret Goggan family is an even better fit after Mary's number has been adjusted.

## Appendix

### Lawrence Powers

The Powers were a confusing family. Lawrence (I) and Honora Powers had a son named Lawrence (II) in 1845 in the first Ward of Syracuse. This Lawrence (II) married a girl named Ellen Googin and they had a son named Lawrence (III) in 1872. Lawrence (II) died in 1873 and his son Lawrence (III) died in 1891 at the age of 18 years. So now there was an Ellen Powers widow of Lawrence (II) living in the First Ward. She died on February 14, 1917.

Going back to Lawrence (I), his wife Honora died somewhere between 1870 and 1875. By 1875 Lawrence (I) had married the widow Ellen Dwyer and had become the step-father to her two girls, Emma (b. 1847) and Mary (b. 1855). Lawrence (I) died on July 28, 1894 and then there was a 2<sup>nd</sup> Ellen Powers, widow of Lawrence (I) living in the First Ward. She died on December 27, 1907.

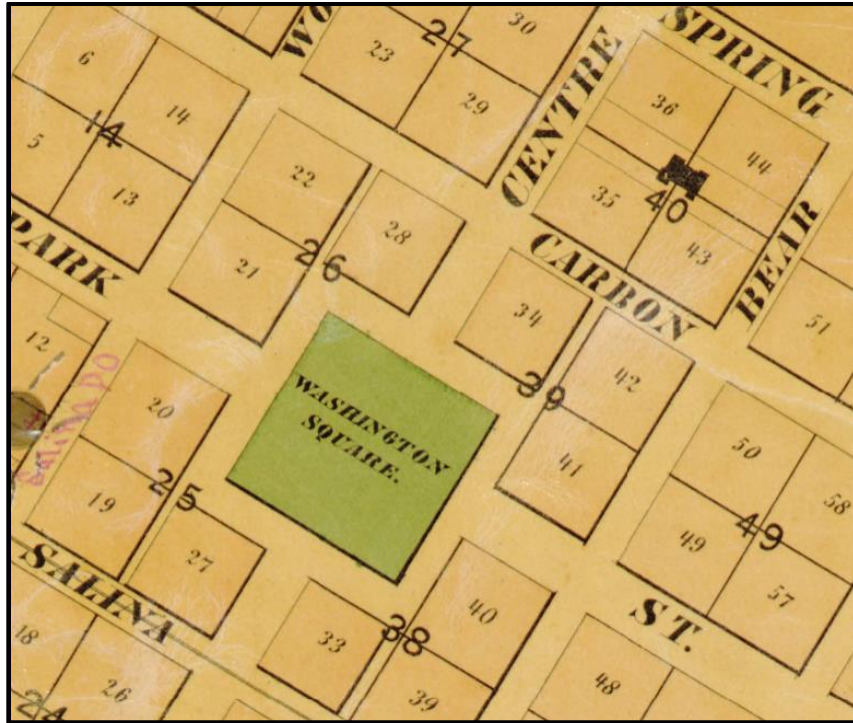

From the names of the defendants in the above foreclosure action it is apparent that Lawrence Powers wasn't just another salt boiler living in the First ward, he owned a company named the Syracuse Fine Salt Company. From the description of the equipment that would be sold along with the properties themselves it is clear that Powers was still employing the older boiler technology to remove the salt from the brine. As the wood supply in the area became depleted the salt manufacturers switched to a solar evaporation technology. Large rectangular trays were exposed to the sun and the water evaporated. Since they were out in the open they needed covers that could be slid over the trays in the case of inclement weather. Anyone familiar with Syracuse weather would have their doubts about a technology that depended on the appearance of the sun.

The technology debate was purely academic since the mining of salt in the mid-west was far cheaper than either the boiling or evaporation method. With the increasingly large number of railroads available this cheaper salt could easily be shipped to the east coast. The salt industry in Syracuse was in a decline from which it would never recover and here was Lawrence Powers being impacted by that decline while employing an old technology. It is no wonder that he was in financial trouble and his properties were being sold at foreclosure.

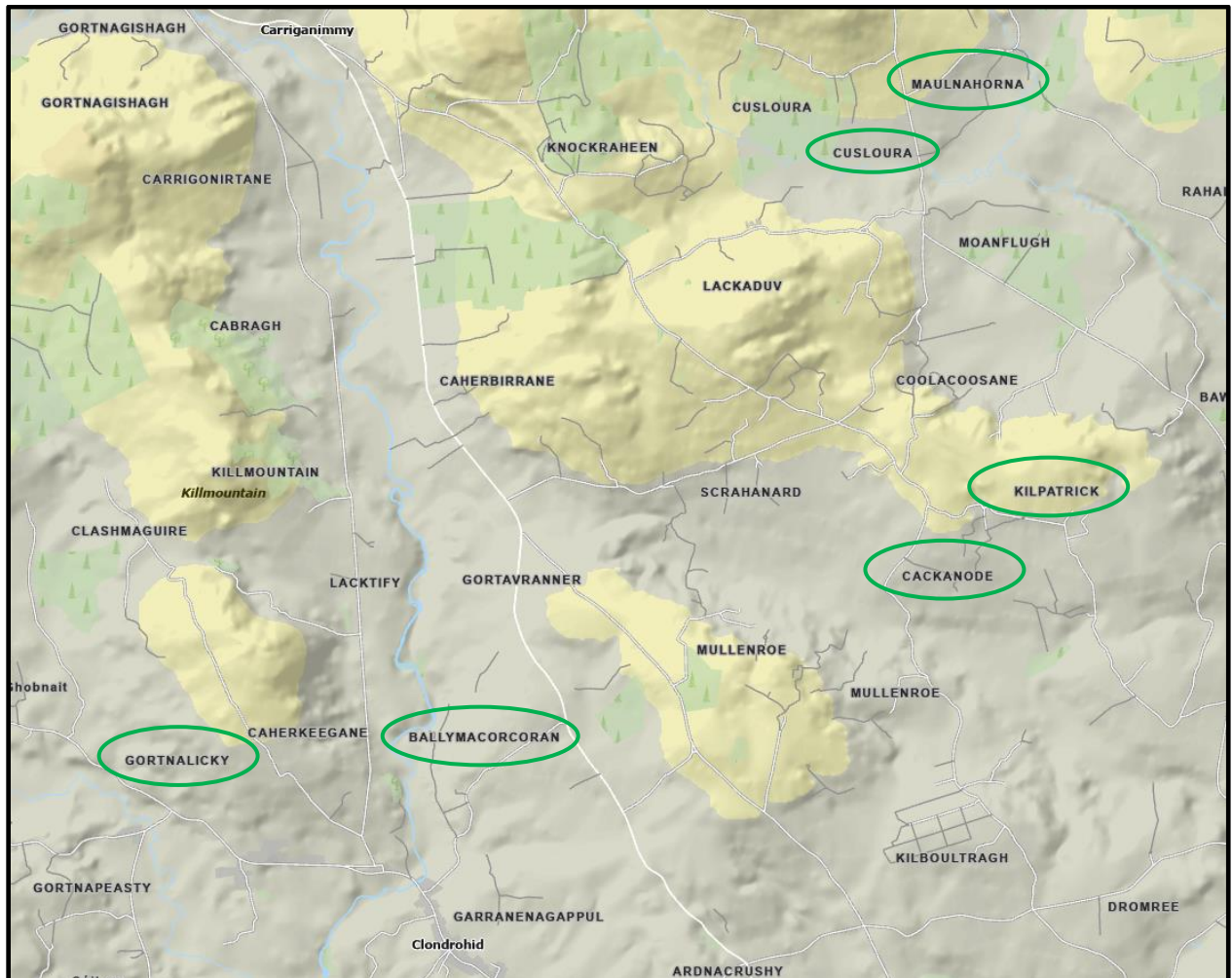

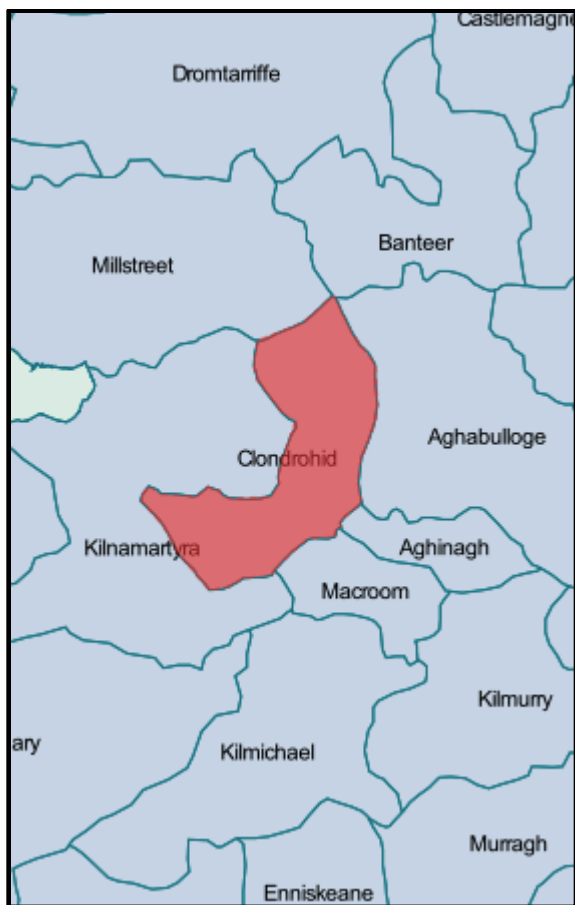

## George H.S. Duckham (1900-1921)

On June 22nd 1921, George H.S. Duckham, was returning to Millstreet from leave in London where he had been married just a week earlier. A young R.I.C. constable in Millstreet, he had rested in Macroom Barrack overnight, and was making his way in plain clothes on a horse and side-car to Millstreet. It was at the height of the war of Independence, and unfortunately for him, the IRA knew he was coming and they ambushed him between Macroon and Carriganima at **Carriganeigh Cross**. They took him prisoner and apparently found on him amongst other things, a list of the names of the members of the Millstreet Battalion Column that were to be shot on sight. On top of that, as a constable he apparently had a bad record in the eyes of the local republicans. He was tried by the IRA and shot. His body was left across the river from Carriganima Church, but apparently taken away and buried in a bog elsewhere by locals who were afraid that the police would cause trouble in the area. His body was never found and remains a mystery. He left behind a young wife and a young son, also named George Henry Samuel Duckham. Wherever his body lies, may he rest in peace.

He is one of four+ R.I.C. (two auxiliaries, two Black and Tans) that lost their lives in Millstreet during the War of Independence. Below are two reports on his demise, and also as some details about his background: [[read more](#) ...]
